Margins: top: 3 cm/ bottom: 3 cm/ left: 3cm / right: 2.5 cm

References and citations: APA-Style (American Psychological Association, 6th edition)

Start date: needs to be agreed with Professor Schober and official registration at the examination office required (Prüfungsamt, Herr Löser)

Deadline: 6 weeks after registration

Start date: needs to be agreed with Professor Schober and official registration at the examination office required (Prüfungsamt, Herr Löser)

Deadline: 4 months after registration

Oral master examination for the Master in Sociology

The module handbook stipulates that after completing the master thesis students also need to pass an oral examination which count towards the MA-colloquium. The examination may take up to one hour and consists of a technical discussion on two topics, which extend beyond the topic of the Master thesis (see also module M6 in the module handbook). The student and the examiner(s) agree on the two topics beforehand. The oral examination can be either done by one examiner and one observer or by two examiners. In the first case, the examiner will be in charge of asking questions and discussing both topics and the observer will take the minutes. In the second case, the two examinors are each responsible for asking questions on one topic.

The module handbook stipulates that after completing the master thesis students also need to defend the thesis in an oral examination. The examination consists of a critical discussion of the Master thesis.
