

## HARVARD STYLE QUICK GUIDE

Beim Harvard-Style wird die Zitation statt in eine Fußnote oder Endnote direkt in den Text eingebunden. Dies ist beim Lesen zwar störend, beim Schreiben jedoch bequemer. Wie In-Style-Zitate eingebunden werden, geschieht in unterschiedlicher Weise.

Bei den Literaturlisten oder Bibliographien („Referenzen“) am Ende der Arbeit gibt es keine wirklich verbindliche Regel, wie man Werke genau aufzuführen hat. Ob man für die Jahreszahl Klammern setzt, die Seitenzahl mit oder ohne „pp.“ angibt oder ob man einen Buchtitel kursiv setzt, ist dem Verfasser überlassen. Was zählt, ist Einheitlichkeit. Für Klammern bei Jahreszahlen und für kursive Buchtitel spricht die bessere Übersichtlichkeit im Gewirr der Bibliographie. Das einzige hervorstechende Merkmal der Harvard-Referenz ist die durchgehende Abkürzung von Vornamen. Ob dies aber bei chinesischen Autoren sinnvoll ist?

### In-Text Citation

Within your text, within brackets:

- Give the author’s surname, or the corporate author, organization, artist, or editor if there is no author (e.g. Smith, Microsoft, Scottish Government).
- Give the year the source was produced (e.g. 2006).
- Give the page numbers if you QUOTE, PARAPHRASE or SUMMARISE words or ideas on a specific page of the source. However, if you are summarizing what an author has argued in an entire book or article, you do not need to give page numbers.
- If you have used the author’s name in the sentence, there is no need to put in the brackets; just the year and page number, if appropriate.

### Quoting directly:

Aitken argues that land fill sites are “not cost efficient” (2006: 48).

### Paraphrasing:

Aitken argues that land fill sites are expensive and inefficient (2006: 48).

### Summarizing an entire book or article:

A recent study reveals new information about child poverty in Scotland (Weir 2007).

### Resources with three authors or editors

There is some opposition to Britain’s future adoption of the euro (Cox, Patel and Pavliotis 2004).

### Resources with more than three authors or editors

Fletcher et al. (2006: 88) suggest that in this century global climate change has caused billions of dollars’ worth of damage.

### Resources with corporate authors or editors

The Dermatology Foundation (2013) stated in their report that “industry also played an important role in the success of the highly rated annual DF Clinical Symposia—Advances in Dermatology.”

## **Resources with no author or editor**

Lisa wasn't scared, she was simply shocked and caught off guard to notice her father in such a peculiar place (Lost Spaces 2014).

## **Resources with no date**

"Her hair was the color of lilac blossoms, while a peculiar color, it fit her quite well" (Montalvo)
