#### Please note:

- Both examiners must be authorized according to §14(2) of the "General Provisions of the University of Tübingen exam regulations for Master's degree programs culminating in an examination for a Master of Science (M.Sc.)/ Master of Arts (M.A.) degree – Master's degree framework exam regulations (MRPO)".
   At least one must be a professor or Privatdozent of the Department of Geosciences, the other must have an examination permit at the University of Tübingen.
  - The examiner and supervisor of the thesis can be the same person, provided he/she has the right to examine.
- According to § 9(2) of the "Examination Regulations, Special Provisions" the Master's thesis cannot be submitted before the end of the fourth month after registration, and must be submitted after six months at the latest.

#### Master's Thesis

- The thesis must be submitted in two bound copies and one file.
   (for degrees according to the 2015 examination regulations: three bound copies)
- The thesis must include a personally signed statement of the independence of the work and the use of cited references according to §28(5) of the "Master's degree framework exam regulations (MRPO)".
- The logo of the University of Tübingen must not be used, as this is not a university publication! This also applies to other university and company logos.

If the deadline for submitting the thesis is on a weekend or a public holiday, the thesis can be submitted on the morning of the following working day.
