


This Year's Topic

The globally dominant way of approaching education has brought about a stand-still. Education is either locked up within a fully technocratic approach (e.g. 'Life Long Learning' or 'what works') or within a critical approach which stems from the tradition of a hermeneutics of suspicion and which aims at debunking 'false consciousness'. Both options render education as a mere means for political aims, instead of regarding education as an autonomous sphere of life (and hence also an autonomous field of research). Moreover, since critical inquiry only stresses the inherent sins and evils of education, there seems to be today no other viable positive way of conceiving of education but taking a technocratic standpoint, which reduces education to the support of individual learning aimed at making the individual respond to social-economic needs. How to go beyond this deadlock? Is it possible and desirable to completely abandon critique? Is there a possibility to stay critical and provide an affirmative account of education that wouldn't be technical? The participants of the symposium will engage in examining these questions from various perspectives, with an emphasis on post-critical pedagogy – a recently developed stance that will be discussed in a greater detail. Different from the mainstream discourses, a post-critical perspective does not instrumentalise education. It is an affirmative approach which aims at rediscovering practices that educational practitioners are already performing, but that seem to be neglected, disregarded or even forgotten.
