Installation Requirements

To ensure operation safety, observe the following conditions:

- Do only operate the Monolith NT.115 instrument with the delivered external power supply (SPU63-105, Sinpro Electronic Co Ltd or Ael60US12, XP Power LLC or GS90A12-P1M, MeanWell or GS60A12-P1J, MeanWell).
- 2. Only connect the external power supply of Monolith NT.115 to an electrical socket containing a protective conductor terminal.
- 3. Ensure that the power plug of the external power supply is well accessible. The Monolith NT.115 instrument has to be installed in a way that it does not hinder the access to the external power supply and its power plug.
- 4. Only operate the instrument with the delivered PC (Notebook).
- 5. Only operate the instrument with original Monolith NT.115 capillary trays.

Installation and Connecting Cables

Preparation

Prepare a table which can bear a weight of about 50 kg and has a free area of 80 cm (width) x 50 cm (depth).

Put the Monolith NT.115 instrument and the Notebook to this free area.

CAUTION The weight of the Monolith NT.115 instrument is approx. 24 kg, do not move the instrument alone (two persons required for transport/movement). If you move the instrument alone it poses a risk of personal injury or damage to the instrument.

Connecting the Power supply and the Monolith NT.115

Confirm that the power switch of the Monolith NT.115 instrument is off (power switch is at the backside, left of the instrument).

WARNING! Do only operate the Monolith NT.115 instrument with the delivered external power supply (SPU63-105, Sinpro Electronic Co Ltd or Ael60US12, XP Power LLC or GS90A12-P1M, MeanWell or GS60A12-P1J, MeanWell). Do only use the delivered cables and plugs. If not doing so you risk electric shock and fire.

Connect the external power supply to the electrical socket. Then connect the power supply to the Monolith NT.115 instrument.

Connect the Monolith NT.115 instrument to the Notebook by using the delivered network cable.

Maintenance and Operation

1. Introduction to Microscale Thermophoresis (MST)

1.1 Outline

Microscale Thermophoresis (MST) is based on a physical principle used for the first time in bioanalytics. It detects changes in the hydration shell, charge or size of molecules by measuring changes of the mobility of molecules in microscopic temperature gradients. It allows fast detection of a wide range of biomolecular interactions from ion or fragment binding up to interactions of large complexes (e.g. liposomes and ribosomes). The main key feature of MST is the possibility to work under close-to-native conditions: Measurements are performed immobilization-free and in any buffer or complex bioliquid (e.g. serum and cell lysate). Other key features comprise easy sample preparation, low sample consumption of less than 4 µl per sample at nM concentration and a high dynamic range of dissociation constants between sub-nM to mM. Furthermore the Monolith NT.115TM is maintenance-free, has low running costs and uses an intuitive software user interface.

1.2 Method

The measurement method is based on the directed movement of molecules along a temperature gradient, an effect termed "thermophoresis". A local temperature difference ΔT leads to a local change in molecule concentration (depletion or enrichment), quantified by the Soret coefficient S_T: $c_{hot}/c_{cold}=exp(-S_T\Delta T)$.

Thermophoresis depends on changes in size, charge and solvation shell of molecules. We monitor the thermophoresis of fluorescent molecules in titration experiments where the buffer is always kept constant. As the buffer is kept constant, alterations in the thermophoretic depletion or enrichment can only arise from changes in the size, charge or solvation entropy of the fluorescent molecules. As the binding of a titrated, non-fluorescent molecule to a labeled molecule changes at least one of these properties, the binding can be quantified by measuring the change in thermophoresis.





Figure 1: Thermophoresis assay: (left) The solution inside the capillary is locally heated with a focused IR-laser, which is coupled into the path of light using a hot mirror. (right) The fluorescence inside the capillary is imaged with a photodiode and the normalized fluorescence in the heated spot is plotted against time. The IR-laser is switched on at t=5s. The fluorescence decreases as the temperature increases and the fluorescent molecules that formed complexes move away from the heated spot due to thermophoresis.

The thermophoretic movement of the fluorescent molecule is measured by monitoring the fluorescence distribution F inside a capillary with the NanoTemper Monolith instrument (Figure 1, left). The microscopic temperature gradient is generated by an IR-Laser, which is focused into the capillary and is strongly absorbed by water. The temperature of the aqueous solution inside the laser spot is raised by 2K-6K compared to the periphery and is thus creating a strong temperature gradient. Before the IR-Laser is switched on a homogenous molecule distribution is observed inside the capillary. When the IR-Laser is switched on, two effects, separated by their time-scales, are observed. As a first response the fluorescence of the dye changes because of its intrinsic temperature dependence. As a second response the molecules move from the locally heated region to the outer cold regions and thus the concentration of molecules in the locally heated region to the outer cold regions and thus the concentration of molecules in the locally heated region to the outer by mass diffusion. (Figure 1, right).

While the mass diffusion D dictates the kinetics of depletion, S_T determines the steady state concentration ratio $c_{hot}/c_{cold}=exp(-S_T\Delta T)\approx 1-(S_T\Delta T)$ under a temperature increase ΔT . The normalized fluorescence F_{norm} measures mainly this concentration ratio, plus a temperature dependence of the dye. In the linear approximation we expect $F_{norm}=F_{hot}/F_{cold}=1-(S_T - dF/dT) \Delta T$. Within the titration experiment F_{norm} changes according to:

$$F_{norm} = (1-x)F(A)_{norm} + x F(AT)_{norm}$$

Where $F(A)_{norm}$ is the contribution of the unbound fluorescent molecule A and $F(AT)_{norm}$ the contribution of the complex of the fluorescent molecule A and its interacting titrant T and x the fraction of fluorescent molecules that formed the complex. By increasing the concentration of the non-labeled titrant and mixing it with a constant concentration of

fluorescent molecule, the fraction of complexes increases until all fluorescent molecules formed complexes with the titrant. Thus the fraction of bound molecules x can be derived from the measured change in normalized fluorescence F_{norm} .



Figure 2: DNA-aptamer binding to Thrombin. (a) The thermophoretic movement of the unbound aptamers differs from the movement of aptamers bound to thrombin. (b) The normalized fluorescence signal of the DNA-aptamer at t=30s is plotted for different concentrations of thrombin to result in a binding curve used for K_d fitting (see section below). As a negative control single strand DNA (ssDNA, blue circles) was chosen. Here no changes in normalized fluorescence signal with increasing thrombin concentration were obtained.

As an example the binding of a labeled DNA-aptamer to thrombin is shown in Figure 2. In this example the concentration of labeled aptamer is kept constant and the thrombin concentration is titrated. Plotting F_{norm} against the concentration of thrombin results in a binding curve from which the dissociation constant K_d can be derived (Figure 2b).

The dissociation constant K_d is obtained by fitting the binding curve with the quadratic solution for the fraction of fluorescent molecules that formed the complex, calculated from the law of mass action. The definition of the dissociation constant is K_d =[A]*[T]/[AT] where [A] is the concentration of free fluorescent molecule, [T] the concentration of free titrant and [AT] is the concentration of complexes of [A] and [T]. The free concentrations of A and T are [A]=[A_0]-[AT] and [T]=[T_0]-[AT], respectively. [A_0] is the known concentration of the fluorescent molecule and [T_0] is the known concentration of added titrant. This leads to a quadratic fitting function for [AT]:

$$[AT] = \frac{1}{2^*} (([A_0] + [T_0] + K_d) - (([A_0] + [T_0] + K_d)^2 - 4^* [A_0]^* [T_0])^{1/2})$$

The concentration of fluorescent molecule $[A_0]$ is kept constant during the experiments and the concentration of titrant $[T_0]$ is varied by titration. The signal obtained in the measurement (equation 1) directly corresponds to the fraction of fluorescent molecules that formed the complex x=[AT]/[A_0] which can be easily fitted with the derived formula to obtain K_d . In the results section of this report the relative fluorescence F_{norm} is plotted in ‰.

2.2 Application Range

The Monolith NT.115 allows to measure the binding of all kinds of biomolecules ($K_d = 1$ nM – 500 mM) as well as the activity of enzymes. Higher Affinities are accessible in competition experiments.

2.3 Sensitivity

The Monolith NT.115 can measure as little as the binding of single ions (40 Da) or small molecules (300 Da) to a target as well as the binding of large complexes such as ribosomes (2.5 MDa).

2.4 Sample Consumption

The Monolith NT.115 requires only little sample material: >1 nM of the labeled compound and a titration of the unlabelled compound in the range of \pm factor 10- to 20-fold of the expected dissociation constant. For standard applications, 4 µl of sample material is filled in the capillary.



2.5 Capillary Format

The capillary format used for the Monolith NT.115 is inexpensive, easy to handle and offers a maximum of flexibility in the experiment scale. The standard sample tray format allows to process automatically up to 16 capillaries (e.g. for a detailed Kd-analysis), or alternatively to perform smaller pilot experiments involving only 2-3 sample concentrations.

2.6 Close-to-Native Conditions

The Monolith NT.115 can monitor the binding and the biochemical activity of biomolecules under close-to-native conditions:

- immobilization-free
- In a solution of choice, ranging from standard and proprietary buffers to complex bioliquids including blood serum, cell lysates, and the like

The Monolith NT.115 is supported by software for instrument control and analysis. For more detailed information see chapter 7 und 8.



3. Samples for MST

For detailed information about handling capillaries please read chapter 5.

3.1 Control Kit - Performing Standard Experiments

Control Kits containing standardized sample material are recommended

- when using the Monolith NT.115 instrument for the first time
- for monitoring the correct performance of the Monolith NT.115
- for training of new lab employees

Optimized Control Kits for use in Microscale Thermophoresis are available either with red- or green-fluorescently labeled biomolecules.

The kits contain a fluorescent-labeled DNA-molecule, unlabeled binding partner and buffer.

3.2 Selecting the Right Monolith NT™ Capillary

In order to avoid experimental artifacts, which can be caused by protein adsorbance to the glass capillary or by protein aggregations, it is recommended to determine the best Monolith NT[™] Capillary type for a biomolecule of interest by performing the following experiment:

- Load 4 Monolith NT[™] **Standard Treated** Capillaries with 100 nM (or with working concentration) of the labeled biomolecule of interest after diluting it with the buffer that is intended to be used in the experiment.
- Place the capillary on the tray and insert the tray in the instrument.
- Chose a folder where to save the scan data and a LED color/power.
- Close the front door and start a capillary scan by pushing the button "Start Cap Scan".

If a "U-shape" (i.e. split peak) is observed, instead of a distinct fluorescence peak, it shows that your sample absorbs to the capillary wall. See figure below (left 3 capillaries):





NOTE: If you observe asymmetry or shoulders in the fluorescence peak repeat the Capillary Scan 5-15 minutes after loading the capillaries.



In this case it is recommended to use Monolith NT[™] **Hydrophobic** and **Hydrophilic Capillaries** which in almost all cases prevent the absorbance to the capillary glass walls.

NOTE: Random variations of fluorescence counts can also be caused by adsorption of the biomolecule to the micro reaction tubes. In this case, a detergent or passivating agents like BSA may be used, a higher sample volume may be prepared or low adsorption micro reaction tubes may be deployed.



3.3 Checking the Sample Quality - Detecting Aggregation

In addition, the potential aggregation behavior of the biomolecule of interest can be tested with Microscale Thermophoresis. Often protein preparations contain aggregates that are very difficult to observe with standard methods. To test for the quality of your preparation perform the following experiment with your molecule of interest at working concentration and in the intended buffer:

Start a measurement with the following setting:

- LED power adjusted to your sample concentration
- MST power 40 %
- MST power on time 30 seconds
- MST power off time 5 seconds

In case that the biomolecule of choice aggregates, the fluorescence signal during the "laser on time" is "bumpy" (examples see next page). This is because aggregates are transported into the measurement volume by a convective flow induced by local heating. Therefore always centrifuge your samples and any stock before using it in a MST experiment (5 minutes, 13000 rpm, 4°C). You may also use detergents such as Tween 20 (0,01 % - 0,1 %) or Triton X-100 (0,01 % - 0,1 %).

4. Preparing MST Experiments

For performing a molecular interaction experiment and measuring the dissociation constant (K_d), a titration series of up to 16 dilutions is prepared, where the concentration of the fluorescent binding partner is kept constant and the concentration of the unlabeled binding partner is varied. Do not use less than 10 capillaries.

NOTE: Also competition experiments can be performed to analyze interactions. E.g. a complex between two proteins is formed, one of them fluorescently labeled. The concentration of this complex is kept constant, and a small molecule or any other competitor is titrated to this complex. When the small molecule is capable of separating the proteins, it is observed in thermophoresis. Thus a functional assay is performed.

A) Prepare the labeled binding partner:

Ideally the ratio of fluorescence label to protein (DEG, degree of labeling) is 1:1 or less. Non-bound fluorescence label has to be eliminated from the labeling mixture, completely. The concentration of the protein should be smaller than or close to the expected K_d and should yield between 100-1500 fluorescence counts (typically equivalent to 1-200 nM) when measured with the Monolith NT.115.

The following kits offer optimized fluorescence labeling and purification protocols for use in Microscale Thermophoresis. The dyes are widely tested with thermophoresis and the protocols are optimized to remove free, non-reacted dye:

B) Prepare the unlabeled binding partner

Prepare a 16 step dilution series around the expected K_{d} , starting from a concentration of 20 fold the expected K_{d} , down to 0.02 fold the expected K_{d} . Prepare the samples with a double concentration, since mixing volume ratio of 1:1 decreases the concentration by a factor of 2.

Use sufficiently small micro reaction tubes to avoid evaporation of the sample (e.g. with a volume < 100 μ l when preparing 10-20 μ l of sample).

C) Binding reaction

After preparing the serial dilution of the non-labeled binding partner, fill 10 μ l of each step of the dilution series into 16 fresh small micro reaction tubes. Afterwards fill 10 μ l of a 2 fold stock solution of the labeled binding partner into the same 16 tubes and mix very well by pipetting up and down. Incubate the samples in the dark. Incubation time and temperature can differ between different molecules and should be tested in a pilot experiment by the researcher. In most cases 5 minutes incubation at room temperature are sufficient.

D) Transfer the binding reaction into Monolith NT[™] Capillaries:

After the adequate incubation time samples from all 16 tubes are aspirated into Monolith NT[™] Capillaries (see chapter 5).



NOTE: When preparing the interaction partners, consider the following rules.

- 1. Centrifuge stock solutions before further usage to remove aggregates.
- 2. When the highest concentration of binder has a significant concentration of an additional buffer component (e.g. 3 % DMSO), then the buffer used for dilution has to contain the additive in same concentration. The same holds true for differences in ionic strength or pH, BSA or glycerol content.
- 3. The Monolith NT.115 has highly precise fluorescence detection and insufficiently mixed samples will be highlighted by random fluctuating fluorescence intensity signals. If sample are well mixed, a random fluctuation of 10 % or even less is achieved.
- 4. In order to avoid bubbles or droplets etc. we recommend to carefully pipett up and down several times and not to vortex these small volumes, that may also lead to denatured protein or sample.



5. Sample Loading

Be careful when using the glass capillaries. Broken capillaries are harmful to skin and eyes. Discard the capillaries only in waste boxes that are intended for use of glass waste. Glass capillaries are not intended for use with infectious samples.

Wear gloves, safety glasses and lab coat.

Stick the Monolith NT[™] Capillary horizontally into the reaction tube to aspirate the sample. Don't touch the capillary in the middle where the optical measurement will be performed.



Position the liquid in center of the Monolith NT[™] Capillary, by holding it vertically and shake it after aspirating the sample. Leave some air at both ends of the capillary.



Put the capillaries in the slots on the sample tray. Note the order of the capillaries. The highest concentration is placed in the front of the tray. This position is denoted as "1" in the sample tray and in the NT Control Software.





Place the sample tray in the instrument by pushing it into the tray slot of the instrument as far as possible. The Monolith NT.115 instrument scans the tray and automatically determines the position of the capillaries on the tray.





6. Using the Monolith NT.115 Instrument

First, start the Monolith[™] NT.115 instrument at the back side and the control notebook. The display of the Monolith[™] NT.115 instrument will show the following picture:



The words "Ready" in the first line and "Connected" in the last line indicate the successful connection between the Monolith[™] NT.115 instrument and the control notebook.

The arrowheads on the right hand side (up and down) are used to open and to close the front door of the instrument in order to load/remove the sample tray.

The activities of the instrument are shown in green letters "MST POWER OFF" and "LED OFF". As soon as an experiment is running these letters turn red and indicate "MST POWER ON" and "LED ON", respectively. The status of the LED informs you if fluorescence detection is running and the status of the MST power if the IR laser is working and generating temperature gradients in your samples.

In the middle of the screen you find information on the "Temperature Control". First of all you can see if the "Temperature Control" is activated ("OFF" or "ON") – this is possible with the NT Control Software (for details see next chapter). Below that you find information on the "Actual Temperature" and the "Target Temperature" of the instrument. Please note that this is not the laser induced temperature gradient used for MST measurements.

For most measurements the room temperature is sufficient, so there is no adjustment necessary.

IMPORTANT! Before running measurements, insert the tray containing capillaries filled with your samples and wait for the "Target Temperature" to be reached!

To start a measurement, start the NT Control Software (for details see next chapter).



7. NT Control Software

With the NT Control Software interface all necessary parameters for the MonolithTM NT.115 instrument can be set. It does not matter if you switch on the MonolithTM NT.115 instrument or the NT Control Software first. After starting the NT Control Software from the desktop, the following screen appears:

7.1 Temperature Control

For using the "Temperature Control" select the "Temperature Control" tool in the upper menu bar and choose the function "Enable Manual Temperature Control". Afterwards type in the target temperature that you want to achieve in the instrument in the "Manual Temperature Control" box and click "On". Please note that this is not the laser induced temperature gradient used for MST measurements. It adjusts the overall instrument temperature.

Now you can also see on the screen of Monolith NT.115[™] instrument that the "Temperature Control" is activated "ON". Further the display reports the "Actual Temperature" and the "Target Temperature". Please wait until the "Target Temperature" is reached (usually less than 5 minutes).

IMPORTANT! Before running measurements, insert the tray containing capillaries filled with your samples and wait for the "Target Temperature" to be reached!

IMPORTANT! Before closing the Monolith NT Control Software and switching off the Monolith[™] NT.115 instrument stop the "Manual Temperature Control" by clicking "OFF" in the "Manual Temperature Control" box.



7.2 Create New Projects or Load Existing Projects

Before starting MST measurements one has to select a file where to save the data. Therefore select the "File" option in the upper menu bar and choose the function "New Project" or "Load Project".

A new window will open in which you select storage medium and file name of your new or an existing ntp-file. Verify by clicking "Save". A ntp-file contains several MST experiments that are listed accordingly to their name and the date & time when they were recorded. A MST experiment can contain several runs that are listed accordingly to the "Table of Runs" that you defined for your assay (e.g. different MST powers).

Afterward creating or opening a ntp-file give a name to the MST experiment that you want to start in the "Actual Experiment's Name" box.





7.3 Define Parameters for MST Measurements

Before starting your MST experiment you have to define the parameters for the MST measurements. Therefore perform the following steps:

1. Select the "LED Color" fitting the dye that you are using in the box "LED Settings".

- 2. Select the number of capillaries that you want to use in your measurement in the box "Capillary Scanning".
- Also select the "LED Power" that you want to use or test in the same box "Capillary Scanning". The "LED Power" can be varied up to 100 %. How to choose the best "LED Power" is described in the next chapter.
- 4. The next step is entering the concentrations of the serial dilution of your titrant (unlabeled interaction partner) in the "Table of Capillaries". How to choose the concentration range best is described in one of the next chapters.
 - a. Therefore choose first the "Dilution" you are using e.g. 1:1.
 - b. Type in the highest concentration of the titrant in capillary "N° 01". This is the first capillary in the tray from the operator's point of view.
 - c. Then after entering the first concentration, move while holding the left mouse button to the concentrations field below. The serial dilution of the concentration will be calculated automatically. Please use only numbers in the column "Concentration".
 - d. The column "Name" accepts both numbers and letters. You can add information in this column like "micromolar AMP" etc...
- 5. The table of runs describes the parameters of the MST measurements that are performed. The "MST Power" is the power of the infrared laser that is used to induce the temperature gradient. Following parameters are listed in the table:
 - a. 5 seconds before the Microscale Thermophoresis is started the initial fluorescence is detected: "Fluo. Before".
 - b. Then automatically the temperature gradient is established by switching on the "MST Power" and the thermophoretic movement is recorded for 30 seconds: "MST On".
 - c. Afterwards the back diffusion is measured for 5 seconds: "Fluo. After". In between runs there is a "Delay" of 25 second. These are the default settings and we recommend sticking to these.
 - d. Also the list of two different "MST Powers" (20 % and 40 %) is a default setting and we recommend sticking to these. When an assay is



established the table of runs can be changed and single runs can be deleted or added (see second example below, runs 2 and 3 were deleted.)

7.4 Choose the LED Power for MST Measurements

Before starting your MST experiment you have to choose the correct "LED Power" and the optimal concentration of the labeled molecule for the MST studies.

Choose the concentration of the labeled molecule according to the following criteria: It should be lower or in the order of the expected K_d . In a typical experiment 5-100 nM of the fluorescently labeled molecule are used.

The "LED Power" can be varied up to 100 %. A good starting value when starting new type of assays is 50 %. Vary the LED power until the maximum fluorescence of the capillaries is between 100 and 1500 counts (optimal 200-1000).

When using a high concentration of the labeled molecule (e.g. 10μ M) you can use a less optimal filter setting e.g. blue filter set for a red dye. This allows you to measure highly fluorescent samples without saturating the detector.

Overexposure / too much "LED Power"

NOTE: Do not work with more than 2500 counts since the detector is saturated. In such a case the MST signal of the molecules cannot be measured. For optimal results chose fluorescence intensity between 100 - 1500 counts (optimal 200-1000 counts).



7.5 The Concentration Finder

The "Concentration Finder" is a tool that will help you to design MST interaction studies. In order to determine the affinity between interaction partners it is important to chose the optimal concentration range of the analyzed molecules. You can either simulate how the binding curve will look like at a certain K_d or you can use the " K_d Interval" if you only know a range of the binding affinity. The tool will help you to choose an optimal concentration of the fluorescently labeled molecule and will determine the best concentration range of the unlabeled molecule. You can open the "Concentration Finder" from the NT Control Software or from the NT Analysis Software, respectively.

After opening the "Concentration Finder" tool the following window appears:



In order to simulate how the binding curve will look like when calculating with a certain expected K_d , please enter the following values:

- 1. No of Capillaries: 1 to 16.
- 2. Concentration (cA): concentration of the fluorescently labeled molecule. It should be lower or in the order of the expected K_{d} . In a typical experiment 5-100 nM of the fluorescently labeled molecule are used.
- Maximum of Concentration (cT): enter the highest concentration of the nonlabeled molecule = titrant.
- 4. Dilution: We recommend doing 1:1 dilution of the non-labeled molecule = titrant.
- 5. K_{d} : Expected dissociation constant.



In order to simulate how the binding curves will look like when calculating with an expected " K_d Interval", please enter the following values:

- 1. To activate the " K_d Interval" tool please click on the small box.
- 2. Enter the expected interval of dissociation constant K_d -Min and K_d -Max.
- 3. Press the "Optimize for K_d Interval" button. The software adjusts automatically the concentration of the labeled molecule (cA) and the concentration range of the unlabeled molecule (cT).





7.6 Capillary Scan and MST Measurement

After preparing the serial dilution of the titrant and mixing it with the fluorescently labeled molecule, load the samples into capillaries and place them into the capillary tray. Insert the sample tray into the Monolith[™] NT.115 instrument and close the door.



Then press the "Start Cap Scan" button and the Monolith NT.115[™] instrument will automatically scan the sample tray by measuring the fluorescence. Therefore capillaries containing fluorescently labeled molecules will result in fluorescence peaks in the lower "Graphic" box. The "Capillary Scan" will start from the last capillary (in the upper example 12, marked with red star) and move to the first position. When the "Capillary Scan" procedure is completed the exact position is annotated for every single capillary in the "Table of Capillaries".

- NOTE: The "Capillary Scan" procedure should not be cancelled otherwise the capillary positions are not stored. When the "Capillary Scan" is used to check for the protein fluorescence intensity, the "Capillary Scan" procedure can be cancelled to adjust the LED power before restarting the "Capillary Scan".
- NOTE: When you want to save an image of the "Capillary Scan" make a right click onto the "Graphic" box and choose "Save Screenshot".
- NOTE: Capillaries that show too little fluorescence are excluded from analysis make sure that the capillary was properly filled with sample. Capillaries that show too little fluorescence are excluded from analysis and the NT Control Software will give you a warning.



After performing the "Capillary Scan" you can start your MST measurement by pushing the button "Start MST Measurement". This will initiate MST measurements in all capillaries starting from capillary in the first position (N° 1) and moving on to the second, third and so on. Further all runs that are listed in the "Table of Runs" will be performed in the capillaries used in the measurement. The second, third and subsequent runs will start again from the first position (N° 1).



After starting the MST measurement in the "Graphic" box the MST curves recorded for every single capillary will be displayed. Here you see on the y-axis the fluorescence (and therefore the thermophoretic movement of the labeled molecule/ complex) that is plotted against the time. You can see which capillary is measured in the moment since this capillary is highlighted in blue in the in the "Table of Capillaries". For analysis of the MST curves recorded for the different capillaries use the NT Analysis Software.





8. NT Analysis Software

The NT Analysis Software allows a quick and a precise evaluation of your Microscale Thermophoresis data and quantification of K_{d} . After starting the NT Analysis Software from the desktop, the following screen appears:



8.1 NT Control Software - Update Mode and Load Function

The NT Analysis has two options for displaying recorded MST curves: Update Mode and Load Function.

8.1.1 Update Mode - Loading MST Curves in Real Time

With the "Update Mode" you can load recorded MST curves directly from the NT Control Software to the NT Analysis Software.

To do so choose the "Update Mode" on the upper right hand side and click the "Update" button. Define the ntp-file that you are currently working on and the NT Analysis will load the recorded MST curves. To load the latest MST curves push the button again.





8.1.2 Load Function - Loading Measurements from ntp-files

With the "Load" button you can load recorded MST curves directly from existing ntp-files to the NT Analysis Software. Please make sure to deactivate the "Update Mode" before.

8.2 MST Data Analysis



After loading the MST curves to the NT Analysis Software of a full binding study (all points of a serial dilution) the following picture will be obtained:

The following analysis modes can be performed: **"Thermophoresis + T-Jump"**, **"Thermophoresis"**, **"Temperature Jump"** and **"Manual"**. While "Thermophoresis" refers to the movement of molecules within the temperature gradient, "Temperature Jump" describes the immediate change in fluorescence yield upon temperature change which is an intrinsic property of each fluorophor.

The last task "Fluorescence" should be checked to check for titrant concentration dependent changes in the fluorescence intensities. For detailed information on this topic please refer to the appendix at the end of this document.



8.2.1 "Thermophoresis with Jump"

Thermophoresis + T-Jump: measures fluorescence change from <u>before</u> the MST power is switched on to the time before the MST power is turned off again thus summarizing both events:



8.2.2 "Thermophoresis"

Thermophoresis: measures the fluorescence change from directly after the temperature jump to the time before the MST-power is turned off:



8.2.3 "Temperature Jump"

Thermophoresis: measures the fluorescence change from directly <u>after</u> the temperature jump to the time before the MST power is turned off:





8.2.4 "Manual"



Manual: allows you to set the cursors manually.

By pushing on the "Cursors Memory" button you can fix the setting and use it for the analysis of multiple MST experiments.



Standard routine for evaluating MST data is the **"Thermophoresis + T-Jump"** settings. With this settings changes in fluorescence intensity due to thermophoresis as well as temperature jump are used to determine binding constants.

Please note that temperature jump and thermophoresis might have opposite directions e.g. temperature jump results in a decrease of fluorescence yield while thermophoretic movement results in accumulation of molecules in the heated spot. In this case temperature jump and thermophoresis have to be separated by applying the **"Thermophoresis"** settings.





In rare cases you can deduce binding information from the temperature jump by employing the "**Temperature Jump**" settings e.g. the fluorescent dye is in close proximity to the ligand binding site thus its fluorescence is changed upon the temperature increase but additionally by the binding of the ligand.

In cases where temperature jump and thermophoresis exhibit the same direction "Thermophoresis + T-Jump" and "Thermophoresis" settings give the same binding constants but might differ in their signal to noise ratio. It is valid to use the settings with the best signal to noise ratio. If the temperature jump changes upon binding it is valid to use the "Temperature Jump" settings as well.

To set the cursors manually using the "**Manual**" option might be important if you observe aggregates or convection in your thermophoresis curve. Then you can place the cursors into a different position of your time traces to exclude disturbance due to aggregation or convection. Data from the early phase of thermophoresis are often less noisy in the beginning of thermophoresis since convection is a time dependent process. Moreover, by separating the two red cursors from each other by several seconds you can average more data points.



8.3 Curve Fitting

After deciding for an analysis setting you can perform a curve fitting. There are two options: the first is to perform a K_d fit according to the law of mass action and the second is to perform a Hill fit according to the Hill equation.

8.3.1 K_d Fitting

Type in the box "Concentr." the concentration of the fluorescently labeled molecule and choose the option "Fix" below. Please note that you have to enter this concentration in the same unit that you used for your serial dilution e.g. AMP was described in μ M therefore enter the concentration of the fluorescently labeled DNA also in μ M: 0.02 μ M and not 200 nM. Afterward press the button "Complete" and then "Fit Curve". The calculated K_d will appear.



8.3.2 Hill Fitting

For fitting your data with the Hill equation, you just have to press the button "Complete" and then "Fit Curve". The calculated EC_{50} will appear.





Note: The values for "Unbound", "Bound" and "Dissociation Constant" can be changed as well. The preview function will plot the graph corresponding to the actual settings, without fitting (i.e. adjusting the values). Pushing the "Border" tab allow to define the concentration range for fitting. This can be used in case of biphasic binding events.



8.3.3 Data point removal

Sometimes there are "outliers" in a data set. They can be due to several reasons: The first reason is aggregation. Take a look at the time trace and if you see a "Bumpy" signal caused by convective flow of aggregates. The second reason is a deviation in concentration. Take a look at the fluorescence of the sample, if the outlier is also an outlier in fluorescence. A third reason for outliers is dirt or water on the outside of a capillary that perturbs the infrared laser.

The outliers can be removed from analysis by clicking on the data point (concentration) in the "Runs" list.



When you perform another analysis this data point is excluded from the calculations.



8.4 Save MST Data

8.4.1 Save as Image File

For saving figures from the NT Analysis Software make a right click onto the picture of interest MST curves, data points or fitted curve box and choose "Save Image As...".



8.4.2 Save as Text File

For exporting your data in a text file format (.txt) select the "File" function in the upper menu bar and choose the function "Export Measurements". A new window will open in which you select storage medium and file name of your new txt-file. Verify by clicking "Save". The txt-file can be opened with most common statistics/graphics software as Microsoft Excel, Origin, Prism and Sigma Plot.



8.5 Generation of MST Report

It is possible to generate a quick report of the obtained data and the analysis, which contains the following information: experiment name, date and time of the measurement, MST power, LED power, the fitting method and the fitted value. Furthermore there are two images showing the MST curves and the fitted binding curve. In this report you can also add comments that will be displayed in the document.

For exporting your data in this way select the "File" function in the upper menu bar and choose the function "Report (html)". A new window will open in which you can enter your comments, then click "Continue >>>". The report will be opened in an html format that can be saved.
