1. Objectives of the Program

The M.A. in American Studies is a consecutive and research-oriented program of study following up on B.A. degrees in English and American studies or other disciplines in literary or cultural studies. It is also geared at graduates of programs in history and the social sciences who have focused on North American politics and societies during their B.A. The M.A. in American Studies allows for a focus on American Literary and Cultural Studies as well as on interdisciplinary approaches to the U.S.A. and Canada. Students learn to recognize central issues, conflicts, and structures that are deemed important in the different areas of studies. The program prepares students to work independently on questions and problems related to North America and to present results in written and/or oral forms. They are able to choose from a wide range of studies and can shape their individual profile which either might be more research-oriented, leading to a PhD in American Studies, or emphasize transfer into a variety of professions. Outside of academia, a Master's degree in American Studies prepares students for jobs predominantly (but not exclusively) in the areas of public relations, adult education, intercultural communication, and similar career fields where a strong background in communicative and intercultural skills, in addition to excellent foreign language skills, plays a crucial role.

Graduates of the program are thus qualified for professional careers outside and inside academia. They have gained a profound understanding of American literature, culture and history from the colonial period to the present. They are able to critically reflect on and evaluate cultural phenomena and the scholarly discourses devoted to it. Furthermore, they may have gained practical experience and know how the skills they have acquired can be made use of outside of academia. The language proficiency of graduates has developed beyond the C 1 level in the area of academic discourse, such as listening and reading for information, orientation, and argument; understanding and discussing scholarly presentations by others, and producing written and oral presentations of original research according to academic conventions of their field.
