The junior research group “Labour and Social Policy in the European Union in the Context of World Financial Crisis, the Euro Crisis and Fiscal Consolidation”, funded by the Hans-Böckler-Foundation and supervised by Prof. Dr. Daniel Buhr and Prof. Dr. Hans-Jürgen Bieling, is at its final stage.
