First statute to amend the statute of the University of Tübingen for the University Selection Procedure in the degree programme of Molecular Medicine with the academic final examination of Master of Science (M. Sc.)

On the basis of § 6 Paras. 2 and 4 of the Higher Education Admissions Act (HZG) dated 22 March 1993 (Law Gazette p. 201) in the version dated 15 September 2005 (Law Gazette p. 630), last amended by Article 2 of the Act of 05 May 2015 (Law Gazette p. 313), §§ 59 Para. 1, Sentences 1 and 2, 63 Para. 2 of the State Law on Higher Education (LHG) dated 01 January 2005 (Law Gazette p. 1) in the version dated 01 April 2014 (Law Gazette p. 99), last amended by Article 2 of the Act of 23 February 2016 (Law Gazette p. 108), and by § 20 Para. 4 of the Higher Education Awarding Regulation (HVVO) dated 13 January 2003 (Law Gazette p. 63, re. p. 115), last amended by the Regulation of 11 June 2015 (Law Gazette p. 396), the Senate of the University of Tübingen adopted the following statute on 11 May 2017.

The statute of the University of Tübingen for the University Selection Procedure in the Master degree programme of Molecular Medicine of 21/06/2012 (Official Notifications No. 10/2012, p. 402), with changed title, is amended as follows.

Article 1

1. In § 1 Area of application, Sentence 1 is revised as follows:

"The University of Tübingen shall award the university places available following the deduction of the advance quotas in the Master degree programme of Molecular Medicine, after the outcome of a university selection procedure."

- 2. In § 2 Deadlines, Sentence 2 is deleted.
- 3. § 3 Form and application is revised as follows:
- a) Paragraph 2 d) regarding a required letter of motivation is deleted.

 The previous Paragraph 2 e) will become the new Paragraph 2 d). The previous Paragraph 2 f) will become the new Paragraph 2 e).
- b) In the new Paragraph 2 e) Sentence 1, the words "in accordance with Level C 1 of the European Framework of Reference" are inserted after the words "English-language skills".
- c) The new Paragraph 2 e) (c) is revised as follows: "Cambridge Certificate of Advanced English Test (Grade A, B or C);
- d) In the new Paragraph 2 e) (d), the words "(...and at least (a) in two of these areas of competence)" are deleted.
- e) In Paragraph 3 Sentence 1, the words "in accordance with § 29 Para. 2 Sentences 5 and 6 of the State Law on Higher Education (LHG)" are replaced by the words "in accordance with § 59 Para. 1 of the State Law on Higher Education (LHG)".
- f) In Paragraph 3 Sentence 3, the words "of § 29 LHG" are replaced by the words "of § 59 Para. 1 LHG".

4. In § 6 Selection criteria, Paragraph 1 Sentence 3 is amended as follows:

Following the words "Basic knowledge in the subjects Immunology, Oncology", the term "Neurobiology" is replaced by the term "Neuroscience", and the term "Infectiology" is replaced by the term "Infection biology".

Within the parentheses, the terms "Microbiology, Parasitology" are included after the terms "e.g. Virology, Medical microbiology".

The words "of 4 ECTS respectively" are replaced by the words "of 6 ECTS respectively".

5. In Paragraph 2 in § 7 Creation of a ranking for the selection decision, after the word "Qualifications", the following note in parentheses is added: "(e.g. competence area of practical knowledge in the area of Molecular Medicine – knowledge or skills from the molecular-biological/-medical laboratory)".

Article 2

This statute shall come into force on the day after its publication in the Official Notifications of the University of Tübingen.
