**Please note:**

- Both examiners must be authorized according to §14(2) of the "General Provisions of the University of Tübingen exam regulations for Master's degree programs culminating in an examination for a Master of Science (M.Sc.)/ Master of Arts (M.A.) degree – Master's degree framework exam regulations (MRPO)". At least one must be a professor or Privatdozent of the Department of Geosciences or the Department of Biology, the other must have an examination permit at the University of Tübingen. The examiner and supervisor of the thesis can be the same person, provided he/she has the right to examine.
- According to § 9(2) of the "Examination Regulations, Special Provisions" the Master's thesis cannot be submitted before the end of the fourth month after registration, and must be submitted after six months at the latest.

Master's Thesis

- The thesis must be submitted in two bound copies and one file.  
(for degrees according to the 2015 examination regulations: three bound copies)
- The thesis must include a personally signed statement of the independence of the work and the use of cited references according to §28(5) of the "Master's degree framework exam regulations (MRPO)".
- The logo of the University of Tübingen must not be used, as this is not a university publication!  
This also applies to other university and company logos.

*If the deadline for submitting the thesis is on a weekend or a public holiday, the thesis can be submitted on the morning of the following working day.*
