Water is a highly relevant topic for environmental historians, in particular when working from a global and transnational perspective. Both inland waters and oceans can be described as topographical, political and social boundaries. At the same time, they are also fluid crossings which help to overcome these physical and ideological demarcations, hence connecting seemingly separated spaces.

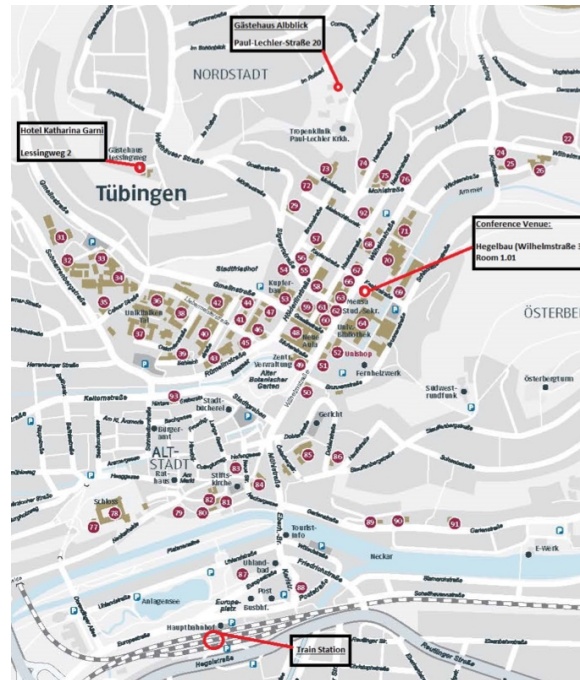
During the 20th century globalization as well as water pollution and consumption developed on a new scale. This raises use conflicts and important research questions. What historical significance have oceans, rivers and lakes as socio-natural sites? What was the impact of global and transnational actors and institutions for the socio-environmental development? What kinds of circulations, controversies and forms of eco-governance emerged?

The conference is organized by two major research associations:

EcoGlobReg is a joint French-German project which deals with the contemporary environmental history of the Soviet Union and its successor states, 1970–2000.

The **Collaborative Research Centre (SFB) 923 "Threatened Order – Societies under Stress"** investigates the manner in which various social orders (from ancient to contemporary history) change, especially when facing threats to their very existence.
