Introduction

In recent years many European countries have embarked on processes of «Energy Transition» in order to provide for sustainable and secure energy supply. Powerful driving forces behind the transition processes are, first, efforts to address the phenomenon of Climate Change by reducing the dependence on carbon fuels, and, second, political decisions to end atomic energy as a civil source of energy supply. The workshop looks into various experiences of national processes of energy transition – inside as well as outside the EU. Building on interdisciplinary foundations the legal experts will present case studies on the different countries blending domestic policy decisions and influences of international and EU Law in view of recent technological and political developments.
