Casa Junior has 15 places for children between the ages of six months and three years.

Childcare places are available for children of employees of the University of Tübingen, for children of university members at the University of Tübingen on a scholarship (e.g. PhD or PostDoc) and for children of guest researchers. As proof, a certificate of the existing employment contract or - if there is no employment relationship - of the scholarship must be submitted (see the end of this application).

Children of students or of employees and members of the Medical Faculty and University Hospitals are not eligible to apply.

The child's parents must be resident in the city of Tübingen or an area administered by the city of Tübingen.

The Casa J**uni**or daycare center is run by Casa KiTaNa gGmbH, which operates another daycare center for 40 children aged 0.5 - 6 years in Tübingen.

Places are allocated by the University's Family Office.
