Rudolf von Sinner, Dr. theol. habil., is professor of Systematic Theology and Head of Graduate Programme in Theology at the Pontifícia Universidade Católica do Paraná in Curitiba, Brazil. He chaired the Global Network for Public Theology form 2020–23 and is Editor-in-Chief of the International Journal of Public Theology. Among his numerous publications is 'Public Theology in the Secular State: a Perspective from the Global South' (Zurich: LIT, 2021).



#### Amanda Vicentini

Pontifícia Universidade Católica do Paraná

Amanda Vicentini is PhD candidate at the Pontifical Catholic University of Parnaá – Brazil, with a period of studies and research at the Katholische Privat–Universität Linz, Austria. Her topics of interest are: ecotheology, feminist theology, indigenous spirituality, and, in particular, the healing and spiritual power of plants.



#### Alexandre Palma

Universidade Católica Portuguesa Theologian, priest and university professor. He obtained his doctorate in theology from the Pontifical Gregorian University (2013). He has taught at the Catholic University and is a researcher at the Research Centre for Theology and Religious Studies (CITER). ## Douglas F. Barros PUC-Campinas



He is the author of Elasticized Ecclesiology: The Concept of Community after Ernst Troeltsch (2017) and Terror and Theologie: Der religionstheoretische Diskurs der 9/11-Dekade (2021) as well as the co-author of The Claim to Christianity: Responding to the Far Right (2020).

Jefferson Zeferino is Associate Professor at the Posgraduate Program in Religious Studies at PUC–Campinas, Brazil. His research focuses on Public Theology and the History of Protestantism in Brazil.
