**Russell West-Pavlov** (co-convenor) teaches and researches comparative Global South cultural and literary studies with foci in the areas of Australia, Africa, and the Caribbean. Particular interests are the poetics of space and time and their transformation in the contemporary moment. He co-convenes the MA Cultures of the Global South and teaches in the Comparative Literature programme in the German Department.

He is currently co-convening a Minor in African Literary and Cultural Studies. He convened a BMBF/DAAD funded Thematic Research Network with six partner universities in the Global South from 2015 to 2020. That network inaugurated the Interdisciplinary Centre for Global South Studies at the University of Tübingen, of which he is a founding board member. He is convenor of the editorial collective of the book series Transdisciplinary Souths (Routledge) and Challenges (Narr).

**Oduma Adelio** (co-convenor) is a lecturer and doctoral researcher in the Department of Anglophone Literary Cultures and Global South Studies at the University of Tübingen. He studied Philosophy and Comparative Literature at the Universities of Oxford, Cambridge, and Tübingen. His research is situated at the intersection of genocide studies, moral philosophy, transitional justice, trauma studies, and literature. His teaching focuses particularly on post-genocide Rwandan literature as well as Caribbean and Black British writing from the 1950s to the present. His first co-authored book *Negotiating Peace, Mediating Conflict* (Routledge 2025 [forthcoming]) explores the microdynamics of peace and builds on the premise that peacebuilding must be reconceptualized in terms of relationality and interconnection.

He previously worked as a researcher at the Guerrand-Hermès Foundation for Peace, where he contributed to the UNESCO Collective Healing Initiative and co-developed the first steps of the UNESCO Future Leaders Academy. He has also conducted research in AI ethics at the International Center for Ethics in the Humanities with various publications examining ethical debates in media and digitalisation.

Nilanjana Premaratna is a Senior Lecturer in International Politics at Newcastle University, UK. Nilanjana works at the intersection of arts, culture, and peacebuilding. Her first book *Theatre for Peacebuilding: The Role of Arts in Conflict Transformation in South Asia* examines the peacebuilding approaches and practices of three theatre groups from Sri Lanka, Nepal, and India. Her current research extends in two directions: first, she explores how different art forms – specifically film, theatre, music, photography, and literature – contend with past violence, present conceptualisations of peace, and imagined futures in Sri Lanka. Second, she investigates regional variations of peace in Sri Lanka and non-liberal approaches to peacebuilding. Nilanjana draws from arts-based methods in her research and has co-curated two Sri Lankan art exhibitions in the UK.
