

Dicta mea sunt dicta patrum.

In the 11th and 12th centuries, there was an unprecedented awakening in the world of Benedictine monasteries: Bernard of Clairvaux, Peter the Venerable, and others struggled for the correct interpretation of the Rule of Benedict. New associations emerged within Benedictine monasticism: Gorze and Cluny suddenly belonged to the old reformers, and the Cistercians referred to the common patristic tradition.

The resulting debates about the correct historical hermeneutics had an impact far beyond the boundaries of Benedictine monasticism, shaping biblical exegesis and playing a decisive role in determining the relationship to one's own past.

This connection has been extensively researched with regard to France. However, there are only a few studies on monasteries in what is now Germany and Poland. A comprehensive perspective has never been ventured, but is certainly worthwhile not only for understanding Benedictine monasticism, but also in the context of the long-standing debates on the relationship to one's own past in Germany and Poland, which continue to shape the present.
