Research interests

Four broad themes characterize my research during the last years: the econometric history of firms and innovations, the study of welfare development and growth in economies around the world, the

long-run development of education and human capital in global perspective, and the determinants and effects of interpersonal violence. The first area of research is based on the idea of creating the world's largest database on the econometric history of firms, 1870-1920. It contains data on profits, capital stocks and other variables of some 19,000 firms (in many cases observed over time). Matched with a sample of 39,000 important patents, we studied the firm creation process and the management strategies that led to innovative and entrepreneurial success.

In the second area of research, I have made extensive use of new anthropometric techniques that allow the study of phenomena, periods and countries that were not previously studied because of insufficient data, also taking care of potential issues of sample selection bias, of course. Important questions that could be answered include the impact of globalization and market integration on inequality and human capital formation. Such questions have important policy implications for today. Recent studies expand the database to countries in the Middle East, Africa, Latin America and other world regions. For example, with Jan Luiten van Zanden (U Utrecht) and other colleagues, we have traced and explained the development of global inequality, which resulted in a volume published by the OECD in 2014, and a large internet database. Jointly with a number of colleagues (and coordinated in the archaeology department by our speaker Martin Bartelheim), we have raised a 20 million Euro grant (in 2013 and 2017) to study 'ResourceCultures' and their interaction with human welfare. This resulted also in a large-scale project with Rick Steckel, Clark Larsen, Charlotte Roberts and others on health, nutrition, violence and work load in the last two millennia.

Thirdly, I am studying the long-run development of education and human capital in long-run perspective, with a special focus on numeracy. For this end, I am making use of the age heaping strategy to approximate numeracy, including many countries in the Middle East, Africa, East Asia, and Latin America. This project has stimulated a large number of colleagues to use our research tool for studying global economic development. One example is the joint project with my former doctoral student Dorothee Crayen and Joachim Voth (Univ. Pompeu Fabra) on the 'natural experiment' of blockade-induced, abnormally high grain prices and the effects on cognitive abilities in England around 1800, which has been published by the Review of Economics and Statistics in 2014.

Fourth, and most recently, I consider determinants and effects of interpersonal violence in global perspective: what encourages violence, and what hinders it? When did the long-term decrease of homicide occur, and why? Do the differences of interpersonal violence have effects on trust-based institutions and hence on economic growth?

All four topics form the base of the global economic history book project that I have recently edited. It will be the first joint study of scholars from all continents on global economic history.
